



## Participation rules Salzburg Trailrunning Festival

By registering, participants acknowledge that the competition regulations and the legal and procedural rules are binding. These rules ensure fair and equal participation in the sport and are legally incontestable. Compliance with and acceptance of these rules is a prerequisite for participation. Each participant is responsible for the technical safety of their equipment and must ensure it complies with the rules. The organizer assumes no liability for accidents, personal or property damage, theft, or other incidents.

### Athlete declaration

1. I declare that I am familiar with and agree to the competition rules and organizational guidelines as stated in the official event announcement and regulations in their latest version.
2. I confirm that there are no medical objections to my participation and that my training and health status meet the requirements of the competition.
3. I acknowledge the health risks and other potential hazards associated with the competition and expressly confirm that I participate at my own risk and responsibility.
4. I assure that neither I nor my legal successors will make any legal claims or demands against the organizer, its employees or contractors, clubs, municipalities, or any other persons or entities involved.
5. I consent to any necessary medical treatment at my own expense in the event of injury or illness during the competition.
6. No claims for reimbursement of registration fees are possible due to force majeure, rescheduling, or cancellation of the event.
7. I agree that photos, video, and audio recordings made in connection with the event depicting me, as well as my name, may be used freely and without compensation by media of all kinds (e.g., TV broadcasts, internet presentations). My image and name may also be used freely for printed materials, including promotional purposes for this or similar events (e.g., brochures, posters).
8. I release the organizer, the organizers, employees, and volunteers from all liability claims unless caused by gross negligence or intentional misconduct not covered by legal liability insurance. This includes all direct damages and claims that I, my legal successors, or other entitled third parties may assert due to injury or death.
9. I agree that my data may be stored electronically and shared with partner companies.
10. I will attend the pre-race briefing and follow the behavioral guidelines presented there.
11. I will follow the instructions of officials and other race personnel.

## Anti-Doping-Code

Participation requires performance without the use of prohibited substances or methods. Accordingly, the following Anti-Doping Code is part of the participation requirements:

1. I reject falsifying or fraudulently enhancing performance through doping, medication abuse, manipulation, or other reckless and deceptive behavior.
2. I commit to abstaining from all prohibited substances that enhance physical performance.
3. I guarantee that I will take medications only when medically indicated and will ensure that prescribed substances, to the best of my knowledge, do not contain any substances listed on the international doping list.
4. I commit that, if found guilty of anti-doping rule violations, I will return any sponsorship, prize, or support funds received in the previous three years to the respective providers.
5. By participating, I consent to doping tests and acknowledge the ÖLV (Austrian Athletics Federation) guidelines and competition conditions.

By registering, I acknowledge the applicable ÖLV regulations, the matters described in the event announcement and regulations, the participation requirements outlined above, and the Anti-Doping Code, and I confirm my agreement. For minors, parental or guardian consent is provided at registration.
